**Eligibility Criteria:**

- (ii) Officers against whom departmental proceedings or criminal cases are contemplated/pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

Selection shall be made on the basis of interview by a Selection Committee.


**Tenure, Terms and conditions:**

- (i) The engagement shall be initially for a period of Two years and may be extended depending on the requirement and satisfactory performance. The tenure of the appointment in no case shall be beyond the age of 65 years of age.
- (ii) Place of posting shall be at the Corporate Headquarters of the respective Utilities i.e for NESCO Utility at Balasore, WESCO Utility at Burla & SOUTHCO Utility at Berhampur.
- (iii) Consolidated remuneration shall be paid at the rate of last pay drawn minus the amount of pension sanctioned per month, subject to maximum of Rs. 40,000/- (all inclusive).
